The XV Edition of the International Conference of Information Commissioners (ICIC) will focus its endeavors around the empowerment of individuals through access to information. This conference aims to bring together information commissioners, experts and stakeholders from various sectors to explore the critical role of access to information under the principles of transparency, inclusivity and accountability in an interconnected world.

The conference will feature panel sessions, parallel sessions, side events, various meetings and ICIC work updates. Panel discussions will include experts from different sectors, providing diverse perspectives on the conference topics. Side events will offer opportunities for in-depth exploration of specific themes or projects related with the mission, vision and strategic priorities of the ICIC. Various organizations will have the opportunity to introduce their initiatives and projects with the ICIC participants promoting the networking among the membership.

In the context of empowering individuals, the conference will address matters around the access to information guarantees for people in vulnerable situations aiming to enhance their right to obtain public information and the exercise of other human rights. These groups encounter various challenges and barriers when speaking about matters such as access to information. The work of information regulators along with relevant public and private stakeholders is essential in finding ways to ensure that these groups exercise their right equally to other individuals. Conference discussants will delve into the aspects preventing, or imposing barriers to people in vulnerable situations for their access to information rights and explore



potential solutions and mechanisms that allow them to consult and use information in an agile way, in an increasingly connected digital world.

The role of media and civil society in promoting access to information is crucial for fostering transparency, accountability, and democratic governance within a society. Both entities play distinct yet interconnected roles in ensuring an information ecosystem where useful and quality information is accessible to the public.

Despite their active role, journalist and media representatives often encounter challenges in accessing or obtaining information and a collective approach from information regulators, civil society, the media and independent journalists, should be exploited in order to have a clearer understanding and make progress in overcoming barriers, but also considering practical aspects.

The delicate balance between privacy rights and the imperative for transparency adds another layer of complexity, as individuals seek to protect personal information while governments aim to ensure public accountability.
